



MOTORBIKE / SCOOTER RENTAL SHORT AGREEMENT (Siem Reap)

Article 1 – Rental Time Rule

The return time equals the pickup time multiplied by the number of rental days.
Example: pickup 10:15 on 01/10 for 2 days → return due 10:15 on 03/10.

Article 2 – Checks Performed Before Taking the Vehicle

The Client declares that, prior to taking possession of the vehicle, the following checks have been performed:

- **Brakes:** tested and found to be in proper working condition.
- **Tires:** visually inspected and in good condition for safe driving.
- **Fuel level:** checked. The Client agrees to return the vehicle with at least the same fuel level as at the time of handover.
- **General condition:** visual inspection completed; no unreported damages noted upon handover.

The Client acknowledges that these verifications were performed before departure and that no major defects affecting safety or usability were found.

Article 3 – Liability

The Client confirms having read and understood the terms regarding damages, accidents, and liability associated with the use of the vehicle. In the event of any damage, accident, theft, or deterioration occurring during the rental period, the client remains responsible in accordance with those terms.

Article 4 – Allowed Area / Distance

Use is limited to **Siem Reap city** and **Angkor Archaeological Park** (approx. **≤ 15 km** from Old Market/Pub Street).

Article 5 – Late Return (based on Article 1)

- Grace: **15 minutes**
- **0–2 hours late: USD 5 per started hour**
- **>2 hours: +1 full extra day**

Article 6 – Breakdowns, Punctures & Recovery

- Inside allowed zone: basic roadside assistance where possible.
- Outside allowed zone: assistance subject to availability; **recovery fee: USD 1.00/km** from the shop, plus any third-party towing/mechanic costs.
- Punctures/consumables (tubes, bulbs, pads) are at the client's cost.

Article 7 – Damage, Accident & Theft

- Client is responsible for any damage, missing parts, misuse (water ingress, off-road, over-revving), and **lost key: USD 20**.
- In accident/theft: ensure safety, **contact the owner**, then **Police** for a report.
- If theft occurs while the vehicle, the client owes **full replacement value**.
- Repairs are done **by Owner or Owner-approved shop** only.

Article 8 – Out-of-Zone Penalty

Leaving the allowed zone without consent: **USD 50 penalty + USD 1.00/km recovery** + any damage/third-party costs.

Article 9 – Fuel & Cleanliness

Return with the same **fuel level** otherwise **USD 5 service + fuel**.
Cleaning for smoke/mud: **USD 5 minimum**.

Article 10 – Helmets & Law

Helmet **mandatory** for rider and passenger. No alcohol/drugs, no racing/stunts/towing, **max 1 passenger**.

Article 11 – Deposit / Document Held

The owner may retain a **physical identity document** (e.g., **passport**) until the vehicle is returned.

The separate **Receipt** lists the item held and pickup details.

Article 13 – Language, Law & Venue

This agreement is in **English**. Governing law: **Kingdom of Cambodia**. Jurisdiction: **Siem Reap**.

Quick Fee Table (for Owner's use)

- Out-of-zone penalty: **USD 50** (+ recovery per km)
- Recovery / towing: **USD 1.00 per km** from shop
- Late return: **USD 5/hour (0-2h)**, then **+1 day**
- Lost key: **USD 20**; damaged helmet: **USD 15**
- Refuel service: **USD 5 + fuel**
- Cleaning (smoke/mud): **USD 10 min**
